The committee discussed the following:

The committee acknowledged the PPL was not used for diverse reasons. The committee advised a statement reflecting these various causes to be added in the section 4.4 of the retrospective review.

4. Amendment Application – Severe Severity

- [REDACTED] [REDACTED] – Addition of a joint bleeding protocol - Provision of an outsourced drug development platform for the treatment of bleeding disorders

In the overall adverse effect section, the committee noted humane endpoints related to a number of bleeding. The committee advised this humane endpoint should be clarified when animals are undergoing the haemarthrosis step.

It was acknowledged that pain is a clinical symptom associated with joint bleeding, but the justification related to the prevention of analgesic administration would benefit from stronger arguments.

The committee advised that pilot studies should be conducted to assess the effect of analgesic on the experimental outcome.

The committee advised that for studies, where pain is not a scientific endpoint, pain relief must be administered.
