#### 1. Minutes

#### 3. Retrospective Reviews

##### (a) [REDACTED] – 70/8112

This licence was granted in 2014.

- In Section 2.1, Protocol 3 is missing despite being listed on the project licence.
- The committee noted the numbers of rats used in Protocol 1 are close to the limit set by the amendment and wanted the licence holder to be aware in case another amendment is needed.
- Clarification is required for severity under Section 2.2
- It was suggested that guidance on use of [REDACTED] is sent to the licence holder.
- Sections 3.1 – 3.7 could be completed more thoroughly.
- In the Condition 18 report, it was noted by the committee that no post mortems had been performed. The licence holder is encouraged to perform post mortems on all cases where animals are found dead of no particular cause.

##### (b) [REDACTED] – 70/7587

This licence was granted in November 2014 and will require a Retrospective Assessment to be completed within 3 months of expiry.

- The 3Rs committee would like to see an explanation as to why no refinement or reduction of contingent harms was possible.
- The committee were pleased with the detail of how the issues surrounding the anaesthetic death had been investigated.



- Concerns were raised regarding the length of time between weight loss checks being too infrequent.

(c) [REDACTED] – [REDACTED]

This licence was granted in November 2014.

- The committee commended the licence holder on the quality of the Retrospective Review and the excellent record keeping which was reflected by this.
- In Protocol 1, the number of adults is close to the estimated total and should be monitored in case an amendment is needed.
- It was suggested that the number of YES/NO questions which remain unanswered are answered.
