 - Should the surgery for the intracranial injection be listed as AC rather than AB. Surgery not mentioned at all in the protocol
 - Steps 2 and 5 in protocol 12 are these mandatory or optional
 - Can the group be sure they are able to maintain the moderate severity
 - Why are the mice be anaesthetized to be handled every time? Is this due to the breed?
 - In protocol 12 step 2 and 3 Hamsters are listed but they don't have Hamsters listed on the species list for this project
