#### 1. Project Licences

#### (a) New licence:

The committee discussed the following:

- The inclusion of specific adverse effects if appropriate as well as specific references in the Project Harms section.
- Information that was included in the researcher's presentation could be usefully included in the Reduction section of the Non-Technical Summary.
- The removal of specific references in the Refinement section of the Non-Technical Summary.
- The inclusion of earlier endpoints and further explanation around how these will be used in the Protocol Justification section of Protocol 1.
- The inclusion of the maximum number of administrations in step 1 of Protocol 1.
- Consideration given to the use of specific models in the Animal Experience section of Protocol 3.

The committee agreed changes were needed before a draft is submitted to the Home Office.

## (b) New Licence:

The committee discussed the following:

- The removal of specific references in the Refinement section of the Non-Technical Summary.
- The inclusion of further detail to explain why current models are not suitable and development of new models is needed in the Scientific Background section of the Project Plan.
- Information included in the researcher's presentation should be included in the Scientific background section of the Project Plan.
- The inclusion of any updates to the framework in the Scientific Background section of the Project Plan.
- Further detail required to explain the scientific need for objective four in the Scientific Background section of the Project Plan.



- Further specificity required regarding specific adverse effects in step 6 of Protocol 1.
- Consideration given to specific treatment options in step 6 of Protocol 1.
- The inclusion of a list of observable signs to help identify specific adverse effects in step 10 of Protocol 1
- The amendment of specific wording in step 10 of Protocol 1.
- The inclusion of clinical observations to help define a specific humane endpoint in the Animal Experience section of Protocol 1.
- The inclusion of a time frame in the Animal Experience section of Protocols 2, 5 and 7.
- Consideration given to the inclusion of a typical and worst-case example in the Animal Experience section of Protocols 2 – 9.
- Further detail required regarding why Protocols 1, 4 and 8 cannot be combined into one protocol.

The committee agreed changes were needed before a draft is submitted to the Home Office.
