- Further information in regards to how all the work leading up to using the large animal has been completed but non-animal or alternative animals were not considered in the Refinement section.
- The addition of any publications and references in the Scientific Background section.
- Further information in regards to specific procedures planned in Protocol 1, Step 2 and 3.
- Further detail in regards to pain relief administration in Protocol 1, Step 2 and 3.
- The recommendation that the applicant checks the anaesthetic codes listed under Protocol 1, step 5 to ensure they are correct.
- Further information around the maximum of occasions and the duration the group can administer specific drugs.

The committee agreed minor changes were needed before a draft is submitted to the Home Office.

(b) New Licence:

The committee discussed the following:

- The benefits mentioned during the applicants presentation included in the Non-Technical Summary of the application.
- Further information and clarification around how the applicant will minimise variables to ensure reproducibility in regards to the Experimental Design section of Protocol 1.
- Further consideration given to the maximum number of uses per animal in Other Considerations under Re-using animals section.
- Several typographical and grammatical errors that require amending.

The committee agreed minor changes were needed before a draft is submitted to the Home Office.



(c) New Licence: was also in attendance)

The committee discussed the following:

- The recommendation that the applicant includes references to the groups extensive background knowledge and publications in the Scientific Background section.
- Further references to data mining as a replacement included in the Non-Technical Summary.
- Further information around the challenges faces and outputs obtained in the Experimental Design section.
- Further information in the Protocol Justification section in regards to scientific endpoints.
- Further description in regards the CSF collection method in the Non-Technical Summary and the relevant protocol.
- Further explanation in regards to the flow diagram 2 in the Action Plan.
- Further information in regards to specific procedures planned included in the Animal Experience section.
- Further information around the minimum start weight for animals undergoing specific procedures in the relevant protocols.
- Updating of the adverse effects for specific procedures planned.
- The recommendation that the animals are monitored more frequently and this added to the How will you monitor for, control, and limit any of these adverse effects section.
- The removal of specific references in regards to end points.
- The committee encouraged the continued refinement of all end points for severe protocols.

The committee agreed changes were needed before a draft is submitted to the Home Office.
