# 1. Project Licences

a) Amendment:

- Further information in regards to the maximum number of times specific procedures can be performed in the Animal Experience section of Protocols 4 and 5.
- Further updating of the flow chart included in the Animal Experience section of Protocol 5.
- Data around the variability the researcher mentioned during the meeting.

The committee agreed changes were needed before a draft is submitted to the Home Office.

- Step 6 of Protocol 2 needs to be split out.

- Further information in regards to the techniques used in Section 3.4.
- The inclusion of references to all animals receiving a full health check and implant survey from the Named Veterinary Surgeons as well as information around the frequency of these checks in Section 3.8.

Overseas Research Request: — The committee reviewed this Overseas research request and had several comments that needed to be addressed:

- Further explanation required for the use of specific animals
- Further rationale and information in the 'What will be done to the animals' section.
- Further explanation in regards to how long the animals were held for and if they will be provided food.
- Further detail in regards to where the animals are coming from and the process of how they will be caught.
- Further information in regards to where the animals will be held between each experiment.
- Further information around why the animals need to be kept for the duration listed.

The committee agreed these comments would need addressing and the form updating before they could give the request ethical approval.
